WATER RIGHTS QUITCLAIM DEED

THIS WATER RIGHTS QUITCLAIM DEED is made and entered into this <u>7TH</u> day of <u>August</u>, 2008, between **Douglas County**, Party of the First Part, hereinafter referred to as "Grantor", and **Town of Gardnerville**, hereinafter referred to as "Grantee."

WITNESSETH:

That said Grantor for and in consideration of the sum of ten dollars (\$10.00), lawful money of the United States of America, in hand paid by the Grantee, and for other good and valuable consideration, the receipt of which is hereby acknowledged, conveys, transfers, and quitclaims to Grantee, and to its successors and assigns forever, all of its right, title and interest in and to the following described water rights on file at the Nevada State Engineer's Office:

That certain 0.77 acres under surface water rights Claim 358-000-00-07; that certain 0.10 acres under surface water rights Claim 367-000-b-00, appurtenant to Assessor's Parcel No. 1320-33-402-014 (previously known as APN 25-322-17); that certain 1.42 acres under surface water rights Claims 385-000-A-18 and 385-000-B-32; that certain 1.81 acres under surface water rights Claim 387-000-00-31.

TOGETHER WITH, all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anyway appearing, and the reversion and reversions, remainder and remainders, rents, issues, and profits thereof.

TO HAVE AND TO HOLD, all and singular, the said water rights with the appurtenances, unto the Grantee, and to its successors and assigns forever.





Dear Carl,

The Town has been actively working on the Martin Slough linear parkway project over the past ten years. During this time significant progress has been made, with three phases completed and another phase funded and in design. Concurrently, the Town of Minden has also completed improvements on the Martin Slough, and cooperatively the two Towns are nearing the goal of a completed intercommunity linkage and pedestrian trail. All of these improvements are compatible with the Gardnerville Plan for Prosperity and the Douglas County Master Plan.

Gardnerville respectfully requests Douglas County to consider transferring all unused water rights in the community held by the County for use specifically on the Martin Slough, and into perpetuity. Additional water rights would help us now, and help the Slough in the long-term by providing irrigation capacity for the riparian areas along this vital parkway project.
