SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 6th day of October, 2008, between JAMES MICHAEL DAVIS and NANCY BARBARA DAVIS, Trustees of THE DAVIS FAMILY LIVING TRUST, dated February 9, 2007, herein called TRUSTOR,

whose address is 1091 Rocky Terrace Drive, Gardnerville, NV 89460

and MARQUIS TITLE & ESCROW, INC., a Nevada Corporation, herein called TRUSTEE and

ROBERT H. WILLIAMS and PATRICIA J. WILLIAMS, Trustees of THE WILLIAMS LIVING TRUST, dated August 7, 2000, herein called BENEFICIARY.

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in State of Nevada, being Assessment Parcel No. 1220-08-812-055, more specifically described as follows: *Woods Co,*

Lot 83, Block E, as set forth on Final Subdivision Map, Planned Unit Development, PD 03-011, for ROCKY TERRACE, filed in the office of the County Recorder of Douglas County, State of Nevada, on November 30, 2005, in Book 1005, Page 12654, as Document No. 661875.

DUE ON SALE CLAUSE:

In the event Trustors sell, convey or alienate the property described in this Deed of Trust securing Note, or contracts to sell, convey or alienate; or is divested of title or interest in any other manner, whether voluntarily or involuntarily without written approval of Beneficiary being first obtained, said Beneficiary shall have the right to declare the entire unpaid principal balance due and payable in full, upon written demand and notice, irrespective of the maturity date expressed in Note.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.

For the purpose of securing (1) payment of the sum of \$450,000.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Deed of Trust.




