TRANSFER OF DECLARANT'S RICHTS

This document takes effect on the 3rd day of October, 2008. It is made by and is binding on:

"Celebrity" - Celebrity Resorts of Genoa, LLC, a Nevada limited liability company. Its principal place of business and post office address is 4700 Millenia Boulevard, Suite 600, Orlando, Florida 32839; and

"Walley's" — Walley's Partners Limited Partnership, a Nevada limited partnership. Its principal place of business and post office address is 213 W. Wesley Street, Suite 200, Wheaton, Illinois 60187.

1. BACKGROUND.

A. Walley's is the "Declarant" named in that certain Fifth Amended and Restated Declaration of Timeshare Covenants, Conditions and Restrictions for David Walley's Resort (the "Restated Declaration"). The Restated Declaration was recorded in the official records of Douglas County, Nevada on August 27, 2001, as Document Number 0521436 in Book Number 0801 at Book Page 6980, and amended and restated in full that certain Declaration of Timeshare Covenants, Conditions and Restrictions for David Walley's Resort recorded on September 23, 1998 (the "Original Declaration"). Pursuant to the terms of the Restated Declaration, Walley's, as the "Declarant," annexed several properties which are subject to the Restated Declaration pursuant to Declarations of Annexation of David Walley's Resort recorded in the official records of Douglas County, Nevada (the "Declarations of Annexation"). The Original Declaration, as amended and restated by the Restated Declaration and further amended by the Declarations of Annexation, is herein referred to as the "Declaration."

Recorded as an accommodation without benefit of a title search.

- Walley's is the "Declarant" of the timeshare program at David Walley's Resort (the "Program") established and governed by the Declaration and other program documents (the "Program Documents").
- C. Walley's desires to transfer and assign all of its rights as the "Declarant" under the Declaration to Celebrity.
- Section 1.9 of the Declaration contemplates the voluntary transfer of Walley's D. rights as the "Declarant."
- 2. TRANSFER OF RIGHTS. In return for money and other valuable things received from Celebrity, Walley's transfers (or, in legal terms, "grants, bargains, sells and assigns") the following rights to Celebrity from and after the date hereof: all rights, powers, and other benefits of the "Declarant" under the Declaration (the "Rights"). As the "Declarant" Celebrity may also transfer its rights as the "Declarant" to another person just as Walley's is doing in this document.
- 3. ASSUMPTION. Celebrity expressly assumes all of Walley's obligations as Declarant under the Declaration; provided, however, Walley's shall retain liability under the Declaration for claims, costs, penalties, fines, damages, losses and liabilities incurred by Declarant prior to the date hereof.
- 4. **BINDING EFFECT**. The promises in this document are binding on and made for the benefit of Celebrity, Walley's, and anyone else who, by law or by agreement, stands in the place of Celebrity or Walley's. (Such people are called, in technical legal terms, "successors," and "assigns.").
