The undersigned claims a lien upon the property described in this notice for work, materials or equipment furnished or to be furnished for the improvement of the property:


1. The amount of the original contract is \$268,749.45.

completing a letter of map revision for the floodplain permitting, completing the annexation process, completing a boundary line adjustment, providing construction staking and any other services needed during construction.

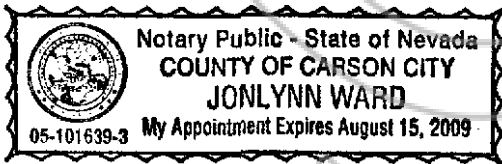
