ASSIGNMENT OF DEEDS OF TRUST

Kingsbury Crossing

WHEREAS, CENTURION RESORTS CORPORATION, a Florida corporation ("Resort") granted a security interest in and collaterally assigned to and in favor of RESIDENTIAL FUNDING COMPANY, LLC, a Delaware limited liability company (f/k/a RESIDENTIAL FUNDING CORPORATION, a Delaware corporation), 2425 East Camelback Road, Suite 500, Phoenix, Arizona 85016, and its successors and assigns ("RFC"), in addition to other Collateral, certain Notes and Deeds of Trust as identified in various Assignments of Deeds of Trust from Resort to RFC, recorded in Official Records, Douglas County, Nevada (collectively the "Collateral"); and

WHEREAS, GMAC Commercial Finance, LLC, a Delaware limited liability company 2425 East Camelback Road, Suite 500, Phoenix, Arizona 85016 ("GMAC CF") has purchased from RFC the underlying loans secured by the Collateral and as part of that purchase, RFC has agreed to assign its interest in the Collateral relating to the Deeds of Trust described on Exhibit A attached hereto (the "Deeds of Trust") to GMAC CF and its successors and assigns.

NOW, THEREFORE, in consideration of the payment of the sum of TEN (\$10.00) DOLLARS and other good and valuable consideration paid by or on behalf of GMAC CF, the receipt whereof is hereby acknowledged, RFC hereby grants, bargains, sells, assigns, transfers and sets over unto GMAC CF all of RFC's interest in and to the Collateral including the Deeds of Trust and any and all other deeds of trust that have been assigned by Resort to RFC and are currently held by RFC even if the reference to such deed of trust was inadvertently left off of Exhibit A or title was taken by RFC after the date Exhibit A was prepared (the "Assignment"). It is the intent of this Assignment to assign all of RFC's interest in the Collateral to GMAC CF. RFC has all requisite limited liability company power and authority to enter into this Assignment and to carry out the transactions contemplated by this Assignment. The execution, delivery and performance by RFC of this Assignment has been duly authorized by all necessary limited liability company action on the part of RFC. This Assignment has been duly and validly executed and delivered by RFC and constitutes a legal, valid and binding obligation of RFC, enforceable against RFC in accordance with its terms, except as such enforceability may be limited by principles of public policy and subject to the laws of general application relating to bankruptcy, insolvency, and the relief of debtors and to rules of law governing specific performance, injunctive relief and other equitable remedies.

IN WITNESS WHEREOF, RFC has caused these presents to be executed in its name, by its proper officers thereunto duly authorized, this 6 day of December, 2008.

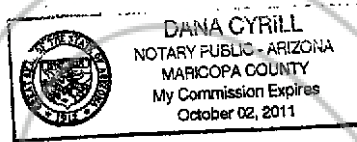
