11 **DECREE OF DIVORCE**

12 This matter having come before the Court on a Complaint for Divorce filed on September 4th,
13 2008, pursuant to § 9-60-020 of the Washoe Tribe Law and Order Code; and the Court having
14 complete jurisdiction as to the subject matter hereof and with good cause appearing therefore,

15 That the Plaintiff and Defendant were married in Reno, Nevada, on the 24TH day of
16 December, 1996, and since then have been, and still are, husband and wife.

17 That the Plaintiff is a resident of the Woodfords Colony and for a period of more than six (6)
18 weeks before the commencement of this action has resided and been physically present and domiciled
19 on the Woodfords, and now resides and is domiciled therein, and during all of said time period,
20 Plaintiff has had, and still has the intent to make said Colony her home, residence and domicile for an
21 indefinite period of time.

22 **IT IS HEREBY ORDERED, ADJUDGED AND DECREED** that the Plaintiff and
23 Defendant be, and each hereby is, granted an absolute and final Decree of Divorce upon the grounds
24 of incompatibility, thereby dissolving the bonds of matrimony heretofore existing between the
25 Plaintiff, **CHERYL ELIZABETH RIVERA**, and Defendant, **ABEL RIVERA RAUDELES**, and
26 each of the parties is hereby restored to the status of a single, unmarried person.

1 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the Wife be
2 restored to her maiden name of CHERYL ELIZABETH SIMMONS.

3 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there are no minor

6 community property hereto be adjudicated by the Court.

8 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that there are no
9 community debts and obligations hereto be adjudicated by the Court. Each party is solely responsible
10 for any debt incurred by that party.

11 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that this Court has
12 continuing personal and subject matter jurisdiction.
