ABSTRACT & CERTIFICATE OF TRUST

The undersigned trustor has established a revocable inter vivos trust which is to be known as the:

The undersigned further declares and certifies that:

1. Billie Jean Tucker, trustor and trustee, deceased December 20, 2002, and the undersigned, Donald Pal Tucker, is the surviving trustor and trustee.
2. The surviving trustor may amend, in whole or in part, or may revoke the trust agreement in writing at any time.
3. The surviving trustee shall have full authority for the trust, to act independently in performing transactions on behalf of the trust.
4. The surviving trustee retains the unlimited right to withdraw income and principal from the trust estate up to the whole thereof as surviving trustee may from time to time deems necessary or advisable. The surviving trustee also retains a general power of appointment which can be exercised by will, or by lifetime transfer over trust property.

5. The surviving trustee/trustor has the power and authority to manage and control, buy, sell and transfer the trust property, in such manner as the trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause inclusion of an irrevocable trust in the estate of a trustee.

6. Upon the removal of the surviving trustee, the successor trustee is designated as DENISE ANN CRAWFORD or if she can not or will not serve then DARRYL PAL TUCKER.

7. Upon the death of both original trustors, the trust estate continues or shall be distributed in whole or in part for the benefit of other named beneficiaries according to the terms of the trust.

8. The identifying number of the trust will be the Social Security Number (or Employer Identification Number) of the trustor on all accounts held in the name of the trust.

9. The situs of the trust is the State of Nevada.

10. The use of this Abstract and Certificate of Trust is for convenience only and the trust agreement is solely controlled by its own provisions and interpretations, and any conflict between this abstract and the trust shall be decided in favor of the trust.

11. The trust has not been revoked or amended to make any representations contained in this certification incorrect.

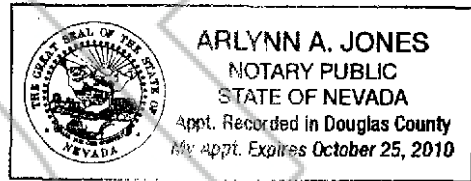
