This legal description was previously recorded on June 24, 2005, as Document No. 119085, in Book 685, Page 1952, in the Official Records of Douglas County, Nevada.



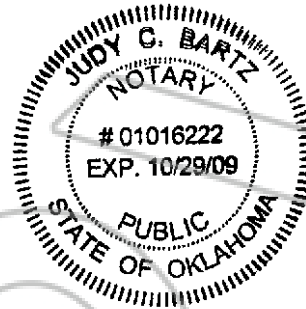

## GRAVESITE DESCRIPTION

All that certain parcel of land situate in the Northeast one-quarter (1/4) of Section 15, Township 13 North, Range 18 East, Mount Diablo Meridian, Douglas County, Nevada, and being more particularly described as follows:

BEGINNING at a point from which the Northwesterly center-line terminous of Paiute Drive, as shown on Sheet No. 2 of the Official Plat of Round Hill Village Unit No. 4, filed as Document No. 31837 in the Official Douglas County Records, bears South  $51^{\circ}38'23''$  West, 425.34 feet distant; thence from the POINT OF BEGINNING North  $89^{\circ}00'00''$  East, 25.00 feet; thence South  $01^{\circ}00'00''$  East, 20.00 feet; thence South  $89^{\circ}00'00''$  West, 25.00 feet to a point on the East sideline of a 20.00 foot wide road easement as described in Book 275 at Page 626 as Document No. 78409 in the Official Douglas County Records; thence along said East side line North  $01^{\circ}00'00''$  West, 20.00 feet to the POINT OF BEGINNING,
