23 IT IS ORDERED that Plaintiffs recover of and from Defendants as follows:

- 24 1. Compensatory damages in the principal amount of \$321,000.00, which is an
25 amount due to Plaintiffs' as alleged in their Complaint;
- 26 2. Interest in the amount of \$48,651.29, with interest to continue to accrue from
27 April 6, 2009 until paid in full, in the amount of \$105.53 per day.
- 28 3. An award of attorneys' fees of \$5,087.50 and costs of \$551.50; and
4. Costs of collection in connection with the Judgment, including reasonable
attorneys' fees, as the Court may award from time-to-time upon application by Plaintiff.
