ORDER APPROVING FIRST AND FINAL ACCOUNT AND REPORT OF EXECUTOR; PETITION ON ACCOUNT OF ATTORNEY FEES AND FOR FINAL DISTRIBUTION OF ESTATE

PAMELA KAPPELHOF, Petitioner herein and Executor of the Estate of LYNN KELLY BROWN, deceased, having rendered to the Court her First and Final Account and Report of Executor; Petition on Account of Attorney's Fees and for Final Distribution of Estate, duly filed on December 17, 2008, this day has been fixed as the time set for hearing of the same.

The Court finds that:

- 1. LYNN KELLY BROWN, died on January 22, 2008, in Carson City, Nevada, and at the time of her death was a resident of Douglas County, Nevada.
- 2. On August 11, 2008 an order was signed by this Court appointing petitioner PAMELA KAPPELHOF Executor of the Estate of said Decedent, to serve without bond, and directing the issuance of Letters Testamentary to petitioner. Letters Testamentary were issued on that date. The Letters have not been revoked.
- 3. The First and Final Account and Report of Executor covers the period from January 22, 2008, to and including the time of the account.
  - 4. The Notice to Creditors has been properly given and that no claims have been filed.
  - 5. The Inventory filed on December 2, 2008 reflects the assets of the Decedent which have

come to the possession of the Executor and are under this Court's jurisdiction. The heirs have divided the decedent's personal property by mutual agreement as provided under the will.

- 6. That due notice of the hearing on the First and Final Account and Report of Executor was duly given as required by law, including the notice to the Administrator of the Welfare Division.
- 7. The Executor retained the services of Nancy Rey Jackson, Attorney at Law, who has assisted her in the administration of the estate and has rendered legal services to petitioner and to the estate.

The Court further finds that the estate is now in a condition to be further settled and distributed.

## IT IS THEREFORE ORDERED, ADJUDGED AND DECREED as follows:

- 1. That the First and Final Account and Report of Executor is in all respects approved, ratified and confirmed as the Final Account and Report of the Executor.
- 2. That, as agreed between the heirs, title to the Decedent's real property, the residence located at 1179 Cottonwood Street, #12, Gardnerville, Douglas County, Nevada, APN: 1320-32-713-008, be transferred to DIANA KELLY SHAW as her sole and separate property. The Executor shall execute the proper deed to effect the transfer. The Court confirms the value of the property at \$160,426.93 as agreed between the heirs.
- 3. That upon the transfer of said property, Diana Kelly Shaw shall pay the executor Pamela Kappelhof the sum of \$52,863.81, such sum representing amounts advanced by Pamela to the decedent personally and to the estate during the period of administration.
- 4. That Diana Kelly Shaw is authorized to set aside to herself the sum of \$40,027.76 from the value of the home as reimbursement of the monies she advanced to the decedent during her life.
- 5. That after the above payments have been made, Diana Kelly Shaw shall pay to Pamela Kappelhof and to Philip Tyler Kelly the sum of \$22,511.79 each, that sum representing their respective shares of the estate. Diana Kelly Shaw shall keep for herself the sum of \$22,511.79 as her share of the estate.
- 6. That the Executor is authorized and directed to pay to Nancy Rey Jackson, Esq. the sum of \$4,153.32 as payment for fees and costs incurred herein.

1	7. That when receipt of distribution is made by the heirs, the estate shall be closed.
