## **INDEMNIFICATION AGREEMENT**

- To the fullest extent permitted by law Hellwinkel shall indemnify and hold Coker-Ewing, Coker-Ewing's officers, directors, partners, and employees from and against any and all costs, losses, and damages (including but not limited to all fees and charges of engineers, attorneys, and other professionals, and all court or arbitration or other dispute resolution costs) resultant from any future claim by or from the Lot Owners, or their successors or assigns, related to the loss of value, merchantability or marketability caused solely by the Lot Owners' having quitclaimed their interest in the subject decreed water rights to Hellwinkel pursuant to separately executed and recorded quitclaim deeds; and
- 2) Coker-Ewing shall release and re-convey, without warranty, to the person or persons legally entitled, the decreed water rights appurtenant to the real property encumbered by the above referenced Deeds of Trust.
