- 12. Borrower Not Released; Forbearance By Lender Not a Waiver. 20. Sale of Note; Change of Loan Servicer; Notice of Grievance. The Note or a partial interest in the Note (together with this Security Instrument) can be sold one or more times without prior notice to Borrower. 22. Acceleration; Remedies.
