On March 24, 1998, my husband, Theodore Henry Bergevin, died and by order of the Ninth Judicial District Court of the state of Nevada, in and for the County of Douglas, in case No. 97-PB-0104, filed June 29, 1998, all of the estate of my deceased husband Theodore Henry Bergevin was assigned and set aside to me as his surviving spouse;
- 8. By deed dated May 1, 2001, my daughter Donna J. Bergevin Steele conveyed her interest in my home to me and all of my daughters, including Donna;
- 9. That Grant, Bargain and Sale Deed dated May 1, 2001, was recorded May 21, 2001, as document # 0514481, at Book 501, Page 5605 of the Official Records of Douglas County, Nevada;
