GRANT, BARGAIN, SALE DEED
Fairfield Tahoe at South Shore

THIS DEED, made this 13th day of April, 2009, by and between **Wendy E. Taylor and Gary D. WITNESSETH:

That Grantors, in consideration of **Five Hundred Dollars (\$500.00)**, to them paid by the Grantees, the receipt of which is hereby acknowledged, have bargained and sold and by these presents do grant, bargain, sell and convey, subject to the terms hereof, unto their heirs, devisees, successors and assigns the following described real property situated in the County of Douglas, State of Nevada:

4. All matters set forth on the plat of record depicting the Fairfield Tahoe at South Shore, and any supplements and amendments thereto.
