**ABSTRACT AND CERTIFICATION OF TRUST**

The undersigned hereby certifies that on December 30, 1986, Louis J. Cardarelli and Esther P. Cardarelli created a revocable estate planning trust. This trust is known as "The Cardarelli Family Trust," with Louis J. Cardarelli and Esther P. Cardarelli serving as original Trustees and Trustees. On March 7, 2009, Esther J. Cardarelli deceased and Louis J. Cardarelli, according to the terms of the Declaration of Trust, serves of sole Trustee.

**THE UNDERSIGNED FURTHER DECLARES AND CERTIFIES AS FOLLOWS:**

**Description of Trust**

The undersigned Louis J. Cardarelli hereby desires to confirm the establishment of the revocable trust on December 30, 1986, and amendments thereto, for the benefit of the Trustees (as husband and wife) and containing, *inter alia*, the following provisions:

1. The Trustees were designated as the Trustees to serve until the death or incapacity of either, at which time the surviving Trustee would serve as the sole Trustee;
2. Upon the death or incapacity of the surviving sole Trustee, the successor Trustee shall be Cheryl Ann Heino, and if not then Stephen John Cardarelli, and if not then Diane Louise O'Brien, to serve alone in that order;

3. Upon the death of either Trustor, the net income of the trust estate shall be distributed or applied to or for the benefit of the surviving Trustor during his or her lifetime;
4. Any Trustee has the power and authority to manage and control, buy, sell and transfer the trust property, in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause inclusion of an irrevocable trust in the estate of a Trustee;
5. Upon the death of both Trustors, the trust estate shall be distributed for the benefit of other named beneficiaries according to the terms of the trust;
6. The Trustees during their lifetimes, or the surviving Trustee, may pay to or apply for the benefit such amounts from the principal of the trust estate up to the whole thereof as the Trustees or the surviving Trustee may from time to time deem necessary or advisable;
7. While both Trustors/Trustees survive, they will use their own Social Security Numbers as tax identification numbers on all accounts held in the name of the trust;
8. The situs of the trust is the state of Nevada;
9. The use of this Abstract of Trust is for convenience only and the trust is solely controlled by its own provisions and interpretations, and any conflict between this abstract and the Declaration of Trust shall be decided in favor of the Declaration of Trust.
