
GRANT, BARGAIN, SALE DEED



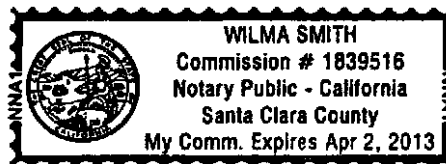

A timeshare estate comprised of:
