## AMENDED ABSTRACT & CERTIFICATE OF TRUST

A Revocable Living Trust has been created which is to be known as:

### **THE BRADDY FAMILY TRUST AGREEMENT executed October 23, 2000**

The original trustees and beneficiaries of this Trust are:

**Walter Raymond Braddy and Charlotte Elizabeth Braddy

Minden, NV 89423**

The undersigned further declares and certifies that:

1. The trustors are designated as the trustees to serve until both of their deaths, resignations or incompetence. Walter Raymond Braddy died on May 25, 2002.
2. The trustors, including the surviving trustor, may amend, in whole or in part, or may revoke this agreement in writing at any time.
3. The surviving trustee has full authority for the trust, to act independently in performing transactions on behalf of the trust.
4. The surviving trustee retains the unlimited right to withdraw income and principal from the trust estate up to the whole thereof as the surviving trustee may from time to time deem necessary or advisable. The surviving trustee also retains a general power of appointment which can be exercised by Will, or by lifetime transfer over trust property.

5. Any trustee or successor trustee has the power and authority to manage and control, buy, sell and transfer the trust property, in such manner as the trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause inclusion of an irrevocable trust in the estate of a trustee.

6. The Braddy Family Trust Agreement U/D/T 10-23-00 has been amended and now provides that upon the death, resignation, removal or inability to act, of the surviving Trustee, the Successor Trustees are designated as Steven Charles Braddy, Karen Elizabeth Harrold and, Janis Lorene Alcott in that order.

7. Upon the death of the surviving trustor, the trust estate shall be distributed in whole or in part for the benefit of other named beneficiaries according to the terms of the trust.


8. The identifying number of the trust, while a trustor survives, will be the Social Security Numbers (or Employer Identification Number) of the trustor on all accounts held in the name of the Trust

9. The situs of the trust is the State of Nevada.

10. The use of this Abstract and Certificate of Trust is for convenience only and the Trust, as amended, is solely controlling as to provisions and interpretations, and any conflict between this abstract and the trust shall be decided in favor of the trust.

11. The trust has not been revoked or amended to make any representations contained in the certification incorrect, and the signature is that of the currently acting trustee.
