1. That I am presently and actually residing on the premises located in Douglas County, State of Nevada, bounded and described as follows:



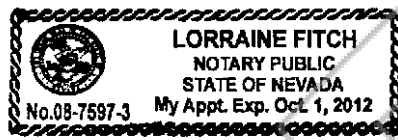
