DEFINITIONS

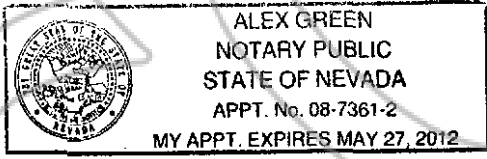
