## GRANT DEED

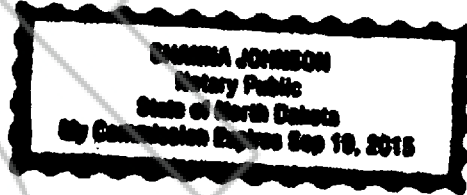




EXHIBIT "A"
