Based upon the foregoing findings, and good cause appearing therefore, distribution shall be ordered as specified below.

- A. The Petition for Final Distribution and Discharge On Waiver of Accounting is hereby confirmed, approved and settled in all particulars.
- B. All acts and transactions of the Executrix relating to the matters set forth in the Petition are confirmed and approved.
- C. The Executrix is authorized and directed to pay to Jeffrey K. Rahbeck, Esq., the sum of \$14,653.68 as and for his services in this matter and also reimburse him for his costs in this matter in the sum of \$468.21.
- D. That after payment of the foregoing fees, the Executrix is ordered and directed to distribute the estate of the decedent in the hands of Executrix in accordance with the decedent's Last Will & Testament, as follows:
 - i. Fifty percent (50%) to DORRENE ROSS.
 - ii. Fifty percent (50%) to ALAN ROSS.
