
**PARTIAL RELEASE AND PARTIAL RECONVEYANCE**

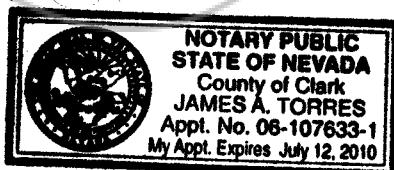
