## IN THE NINTH JUDICIAL DISTRICT COURT OF THE STATE OF NEVADA IN AND FOR THE COUNTY OF DOUGLAS

ORDER SETTING ASIDE ADMINISTRATION

It appearing to the satisfaction of the Court that a verified petition to set aside the Nevada estate of the above-named decedent without administration has been filed, and the notice of the time and place of the hearing thereon has been duly given in this matter in the manner and for the period required by law, and that no one has objected or presented any reason why the petition should not be granted;

The Court finds that the gross value of the Nevada estate of William T. Clarke does not exceed the sum of \$100,000; that the decedent left no debts in the state of Nevada nor debts anywhere that need to be satisfied out of the property of the decedent situate in the state of Nevada; that the expense of last illness and burial charges have been paid; that the decedent left no minor children or surviving spouse; and that the heir of the decedent, Diljit Singh, is entitled to receive the whole of the estate pursuant to NRS 146.070 as the heir of the decedent.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

- That the gross value of the Nevada estate of William T. Clarke, does not exceed the 1. sum of \$100,000:
