This Agreement to Indemnify and Hold Harmless ("Agreement") is entered into between Oscar Reese and Douglas County on the 7 day of January, 2010.

I, Oscar Reese understand that NAC 445A.6672(2)(c) requires the Douglas County Public Works Department to "[e]nsure that the residual pressure in the distribution system is ... [a]t least 40 psi during maximum day demand." I agree that in exchange for Douglas County allowing me to connect to its water main at APN 1319-09-701-004, I will indemnify and hold harmless Douglas County, including any department or division thereof and any employee, officer, agent or representative thereof (hereinafter "Douglas County"), against all expenses and liabilities arising from the pressure conditions.

In exchange for such indemnification and agreement to hold harmless, Douglas County through its Department of Public Works, will allow Oscar Reese to connect to its water main and install a privately-owned pump on the service lateral at APN 1319-09-701-004, which will ensure such pressure requirement is met or exceeded.

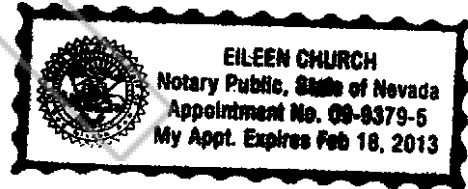
