



23 This cause having been considered by the Court on Plaintiff's Motion for Judgment by Default
24 and Motion for Attorneys' Fees, the Affidavit of Gary M. Fuller, Esq. and the Clerk of the Court
25 having entered default in favor of Plaintiff and against Defendants, MAHGOYUT ENTERPRISES,
26 LLC, a Nevada limited liability company dba INCLINE WINE & CHOCOLATE fka THE

1 VILLAGE GOURMET and DANIEL URSITTI individually, on October 13, 2009, for their failure
2 to plead or otherwise defend within the time allowed by law, therefore, it is hereby

3 ORDERED, ADJUDGED AND DECREED that Plaintiff has judgment against Defendants
4 MAHGOYUT ENTERPRISES, LLC a Nevada limited liability company, dba INCLINE WINE
5 & CHOCOLATE fka THE VILLAGE GOURMET and DANIEL URSITTI individually in this
6 action for the sum of SIX THOUSAND EIGHT HUNDRED THIRTY SEVEN and 85/100
7 DOLLARS (\$6,837.85), plus accrued interest in the amount of FOUR HUNDRED FIFTY ONE
8 and 58/100 DOLLARS (\$451.58), and interest thereafter at the contract rate of 18% per annum,
9 which is a daily rate of \$ until paid, together with costs incurred in the sum of \$ 317⁰⁵ and
10 attorneys' fees only against Defendant DANIEL URSITTI in the amount of \$ 1,512.⁵⁰


