- 5. That the ancillary property in Nevada is a home located at 209 Laura Springs Court, Gardnerville, NV 89460-6221; APN 1319-34-002-009. The value of said property is estimated between Three Hundred, Ninety Thousand Dollars (\$390,000) and Four Hundred Thousand Dollars (\$400,000.00).
