ABSTRACT AND CERTIFICATION OF TRUST

The undersigned hereby certify that on March 9, 2010, they created a revocable estate planning trust. This trust is known as "THE BENNETT FAMILY TRUST, dated March 9, 2010," with Larry Wayne Bennett and Glenda Lynn Bennett, Trustors and Trustees.

THE PARTIES FURTHER DECLARE AND CERTIFY AS FOLLOWS:

Description of Trust

The parties hereto desire to confirm the establishment of a revocable trust on March 9, 2010, and amendments thereto, for the benefit of the Trustors (as husband and wife) and containing *inter alia* the following provisions:

- The Trustors are designated as the Trustees to serve until both of their deaths, 1. resignations or incompetence.
- 2. Upon the removal of both original Trustees, the Successor Trustee is designated as Holly Ann Dellamalava. If, for any reason, Holly Ann Dellamalava shall fail to qualify or cease to act as trustee, then Daniel Wayne Bennett is designated to act as alternate Successor Trustee.
- 3. Upon the death of either Trustor, the surviving spouse is vested with a life income from Trusts A and B, and the Trustee may invade principal for the benefit of the surviving spouse as determined by an ascertainable standard. It is intended that

Trust B qualify for the marital deduction under Internal Revenue Code Section 2056.)

- 4. Any Trustee/Trustor has the power and authority to manage and control, buy, sell and transfer the Trust property, in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause inclusion of an irrevocable trust in the estate of a Trustee.
- 5. Upon the death of both trustors, the Trust estate shall be distributed to those named beneficiaries according to the terms of the Trust.
- 6. The Trustees during their lifetimes, or the surviving Trustee, may pay to or apply for the benefit such amounts from the principal of the Trust Estate up to the whole thereof as the Trustees or the surviving Trustee may from time to time deem necessary or advisable.
- 7. While both Trustors/Trustees survive, they will use their own Social Security Numbers as tax identification numbers on all accounts held in the name of the Trust
- 8. The situs of the Trust is the State of Nevada.
- 9. The Trust contains a spendthrift provision.
