AGREEMENT – Amendment #1

This agreement is made and entered into between Douglas County, State of Nevada, a political subdivision of the State of Nevada, (County), and the Nevada Tahoe Conservation District (NTCD), a political subdivision of the State of Nevada.

RECITALS

1. The County and NTCD are public agencies under NRS 277.100 and NRS 548.340 respectively, and public agencies may contract with any other public agencies to perform, under NRS 277.180, NRS 548.360 and NRS 548.380, any governmental service, activity or undertaking that a contracting agency is authorized to perform. Each is authorized to designate matching funds for use in matching U. S. Forest Service grants for the health, safety and welfare of the citizens of the County or District.

2. NTCD desires to use County-spent State money as matching funds for NTCD's environmental monitoring grant with the U.S. Forest Service Lake Tahoe Basin Management Group (USFS) (grant # 06-DG-11051900-028) in the amount of \$15,651. The funds must be used within a set time period or be lost for use in grant matching. The County is unable to use the funds for a match. Both the County and the NTCD mutually agree that the use of matching funds would benefit the general public.

AGREEMENT

In consideration of the mutual promises contained in this agreement the parties agree as follows:

1. The County has spent at least \$191,651 (\$181,000 plus the additional \$15,651) in nonfederal State funds on the Oliver Park/Kahle Drive Water Quality Improvement Project between July 1, 2006 and December 31, 2006 (see Attachment A - Spreadsheet summary.) That money has not been used for a grant match for any other federal funding. The County agrees that the District may use \$15,651 spent on the project for matching funds for the NTCD's environmental monitoring grant with the U.S. Forest Service Lake Tahoe Basin Management Group (USFS) (grant # 06-DG-11051900-028).

2. The County will not be responsible for any costs connected to the use of these matching funds or with the monitoring program and the parties agree that no liability will

transfer to the County.

3. This agreement will become effective only after it has been ratified by official action of the governing bodies of the each party.

4. Each respective party agrees to indemnify and hold harmless the other party, to the extent provided by law, including, but not limited to, NRS chapter 41, from and against any liability arising out of the performance of the agreement proximately caused by any act or omission of its own officers, agents, and employees.

5. The laws of the State of Nevada apply in interpreting and construing this agreement.

6. This agreement constitutes the full and final agreement between the parties and will not be modified except in writing and signed by both parties.

7. This agreement may not be assigned except by writing signed by both parties.
