RE: Cave Rock, Phase I, Grounding Issues

I visited the Cave Rock, Phase I project at request of Dominick because of problems with the underground power feed from Cave Rock WTP to intake and to the valve vault. This is existing work which is not a part of the contract. Dominick found that the 480 volt, I phase power feeder from the intake to the valve vault is damaged and is shorting.

We looked at each location and found the following issues with the existing power systems.

- A. Intake. The station grounding is incomplete and the ground electrode (grounded to a painted bolt on a pipe flange) is inadequate. The following additional work is needed:
 - 1. Establish a new ground electrode by driving at least 2 ground rods outside the lake intake building.
 - 2. Run #4 AWG ground wire from the ground rods to the 480 volt service panel ground bus.
 - Run #6 AWG ground wire from 480 volt service panel ground bus to 120/240 volt Panel A ground bus.
 - 4. Run #6 AWG jumper from Panel A ground bus to Panel A neutral bus.

- 8. Be sure all panel and wire way sheet metal is grounded.
- 9. Ground new pumps back to new VFD panels and back to 480 volt service panel.
- B. Cave Rock WTP. Make sure the 480 volt service neutral is solidly grounded at the service panel.
- C. Valve Vault.
 - Either replace underground feeder wires from intake to valve vault or establish a new 120/240 volt service for the valve vault at the vault.
 - 2. Check existing ground electrode system to be sure it is good or install new ground.
 - 3. Ground all enclosures and the 120/240 volt system neutral.

Action:

- 1. The valve vault is not a part of the contract and I believe Dominick will take care of the new service.
- 2. The County needs to decide if they want the existing intake power system grounding work done by the contractor or if the County wants to do it. If the contractor is to do it we need to write a proposed change order.
- I believe Dominick will look at the grounding at the Cave Rock WTP.
