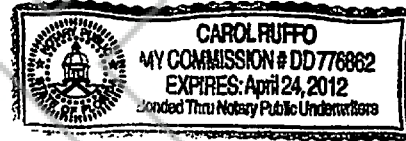

A Timeshare Estate comprised of:

Parcel 1:
