WITNESSETH:

WHEREAS, on July 12, 2007, the parties entered into Agreement No. PR439-07-063 to delegate authority to the County to design, advertise, award, and manage construction of sidewalk and curb ramps along Lake Parkway West and East near U.S. 50 in Stateline; and

WHEREAS, this amendment reduces the project limits and extends the agreement termination date for the PROJECT; and

WHEREAS, the parties hereto desire to make certain amendments to Agreement No. PR439-07-063.

NOW, THEREFORE, the parties agree as follows:

- A. Witnesseth, the 4th Paragraph, is amended by deleting it in its entirety and inserting in its place: "WHEREAS, this Agreement is intended to delegate authority to the COUNTY to design, advertise, award, and manage construction of sidewalk and curb ramps along Lake Parkway East as outlined in the Project Scope attached hereto and incorporated herein as Attachment A-1, hereinafter called the PROJECT; and"
- В. Article II, Paragraph 1, is amended by deleting it in its entirety and inserting in its place: "To perform or have performed by consultant forces: (a) the design of the PROJECT (including the development of plans, specifications and estimates); (b) the completion of the NEPA documentation in conformance with 23 C.F.R. § 771; (c) the acquisition of environmental permits and clearances; and (d) the advertisement, award and construction management of the PROJECT, as outlined in Attachment A-1, in accordance with Federal, State and local laws, regulations, ordinances and policies, including but not limited to those listed in the FHWA "Contract Administration Core Curriculum Participant's Manual Reference Guide" and http://www.fhwa.dot.gov/programadmin/contracts/coretoc.cfm, incorporated herein by reference. The PROJECT shall be designed and constructed in accordance with COUNTY standards. The PROJECT shall be operated and maintained in accordance with applicable Federal, State and local laws, regulations, ordinances and policies."
- C. Article III, Paragraph 1, is amended by deleting it in its entirety and inserting in its place: "The term of this Agreement shall be from the date first written above through and including December 31, 2011, or until the construction of all improvements contemplated herein have been completed and accepted by the DEPARTMENT, save and except the responsibility for maintenance as specified herein."
- D. Attachment A is amended by removing it in its entirety and replacing it with the attached Attachment A-1.

E. All of the other provisions of Agreement No. PR439-07-063 dated July 12, 2007, as amended by Amendment No. 1 dated November 12, 2008, and Amendment No. 2 dated December 2, 2009, shall remain in full force and effect as if set forth herein.


