21 unpaid base rent, late charges in the amount of \$1,215.00, and
22 interest in the amount of \$1,891.55 for a total amount of rent, late
23 fees and interest of \$15,808.56. In addition to these amounts,
24 Plaintiff is entitled to attorney's fees in the amount of \$4,279.45
25 and costs totaling \$486.38. The Court finds that such amounts are
26 reasonable based upon the factors outlined in *Brunzell v. Golden Gate*
27 *Nat'l Bank*, 85 Nev. 345, 349 (1969).
