Trustor, payable to order of Beneficiary, and extensions or renewals thereof; (2) the performance of  
each agreement of Trustor incorporated by reference or contained herein or reciting it is so secured;  
(3) Payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or his  
successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by  
this Deed  
of Trust.


