WATER RIGHTS QUITCLAIM DEED

THIS INDENTURE is made and entered into this 2 day of ________, 2000 between David L. Graham, Trustee and Lisa D. Graham, Trustee of the David and Lisa Graham's 1994 Family Trust created December 6, 1994, hereinafter referred to as "Grantor", and Gary D. Minter and Lisa A. Minter, husband and wife, hereinafter referred to as "Grantee".

WHEREAS, David L. Graham, Trustee and Lisa D. Graham, Trustee of the David and Lisa Graham's 1994 Family Trust created December 6, 1994 (hereinafter collectively referred to as "Graham Family Trust"), sold Douglas County, Nevada Assessor's Parcel No. 1220-30-002-010, together with all hereditaments and appurtenances to Allen B. Gates and Nancy M. Gates, Trustees of the Allen B. Gates and Nancy M. Gates Family Trust dated October 14, 1994 (hereinafter collectively referred to as "Gates Family Trust"), by Grant, Bargain and Sale Deed recorded as Document No. 0532080, Book 0102, Page 2841, in the Official Records of Douglas County; and,

WHEREAS, concurrently with the execution of that Grant, Bargain and Sale Deed (Doc. No. 0532080), the Graham Family Trust also executed and caused to be recorded a Water Right Quitclaim Deed in favor of the Gates Family Trust purportedly conveying certain water rights known or understood to be appurtenant to Assessor's Parcel No. 1220-30-002-010. This Water Right Quitclaim Deed was recorded as Document No. 0532081, Book 0102, Page 2841, in the Official Records of Douglas County. Regrettably the description of the water rights conveyed to Gates Family Trust by this Water Rights Quitclaim Deed errantly referred to the amount of water being conveyed in "acre-feet annually" rather than "acres" as intended by the parties, Graham Family Trust and Gates Family Trust; and,

WHEREAS, subsequently, by separate Water Rights Quitclaim Deed concurrent with the sale of the underlying real property, Assessor's Parcel No. 1220-30-002-010, Gates Family Trust conveyed its interest in certain water rights to Gary D. Minter and Lisa A. Minter. This subsequent Water Rights Quitclaim Deed was recorded in the Official Records of Douglas County as Document No. 0690414, Book 1206, Page 3194, the description for which accurately reflected that the amount of water rights being conveyed was listed in "acres".

WHEREAS, the Graham Family Trust, as Grantor, desires to remove any potential confusion that may result from the errant listing of the amount of water rights previously conveyed by that certain Water Rights Quitclaim Deed referred to above as Document No. 0532081.
