NOTICE OF ATTACHMENT OF AN OPEN TAX LIEN ON AGRICULTURAL REAL PROPERTY IN DOUGLAS COUNTY

Due to a successful filing of a current or prior agricultural or historical application, per NRS 361A.110, the property may be subject to liens for undetermined amounts. Also, pursuant to NRS 361A.155, when any portion of agricultural land is converted to a higher use the county assessor shall determine its taxable and agricultural use values against which to compute the deferred tax for each fiscal year the property was under agriculture or historical assessment during the current fiscal year and the preceding six fiscal years, or such other period as is required pursuant to subsection 2 of NRS 361A.280.

In accordance to NRS 361.270 the owner will, within thirty days after a parcel or any portion of a parcel of real property which has received agricultural use assessment ceases to be used exclusively for agricultural or historical use, notify the county assessor in writing of the date of cessation of that use. Pursuant to NRS 361A.280 all deferred taxes will become due along with penalties if the owner failed to file the notice required by NRS 361A.270. Also, according to NRS 361A.290, if there are deferred taxes that have not been paid under provisions of NRS 361A.265 or 361A.280 at the time real property is sold or transferred, the seller must notify the buyer in writing that there is a lien for deferred taxes on the property.

The following list contains real properties, which have current or prior approved applications for agricultural or historical assessment and have active liens filed against them.

You will please take further notice that deferred taxes on all qualified agricultural real property in Douglas County will annually attach as a perpetual lien under NRS 361A.280(3). Persons desiring information regarding these liens should contact the Douglas County Assessor's Office.
