18 Upon the Stipulation for Judgment executed by the parties hereto, Plaintiff, CAPITAL

19 ONE BANK (USA), N.A., ("Plaintiff"), by and through its attorney, JEFFREY G. SLOANE,

20 ESQ., of the firm of KRAVITZ SCHNITZER SLOANE JOHNSON & EBERHARDY, and the

21 Defendant, NORMA REECE, ("Defendant") that the Plaintiff has Judgment against said

22 Defendant for the principal sum of \$996.84 plus accrued interest in the sum of \$978.31 together

23 with interest on the principal sum at the rate of 20.65 percent per annum from October 4, 2007,

24 plus attorneys fees in the amount of \$220.00 and court costs of \$49.00, and all costs accrued after

1 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff have
2 Judgment against said Defendant for the sum of \$996.84, together with interest at the rate of
3 20.65 percent per annum from October 4, 2007, plus attorneys fees in the amount of \$220.00 and
4 court costs of \$49.00, and all costs accrued after Judgment.

6 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the aforementioned
7 Judgment shall be paid as follows:

8 On or before the TWENTY-THIRD (23RD) day of MAY, 2008, Defendant shall pay to
9 Plaintiff TWO HUNDRED FIFTY AND 00/100 Dollars, (\$250.00), and then;

11 Beginning on or before the TWENTY-FIFTH (25TH) day of JUNE, 2008, Defendant
12 shall pay Plaintiff ONE HUNDRED AND 00/100 Dollars, (\$100.00), per month, and a like
13 amount on or before the TWENTY-FIFTH (25TH) day of each month thereafter until the full
14 amount of the Judgment has been extinguished.

15 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that payments shall be
16 made payable to "KSSJE" and delivered or mailed to the offices of KRAVITZ SCHNITZER
17 SLOANE JOHNSON & EBERHARDY, Attention: Payments, P.O. Box 98813, Las Vegas, NV
18 89193 and shall be received by said offices on or before the aforementioned dates, referencing
19 Account 5178052177823966 on all payments.

21 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that in the event the
22 Defendant fails, neglects or refuses to pay any such payment on or before its due date, then all
23 sums remaining due under such Judgment shall become due and owing and entry and execution
24 may thereupon issue without benefit of notice to the Defendant.

26 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment in full
27 of the amounts aforementioned in the manner provided for herein, Plaintiff shall file a
28 Satisfaction of Judgment.



1 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment in full
2 of the amounts aforementioned in the manner provided for herein, Plaintiff shall extinguish all
3 lien rights it may have in any property of the Defendant.


4 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that pursuant to Nevada
5 Rules of Civil Procedure 41(e) that enforcement of this Judgment may be made by Plaintiff
6 against Defendant at any time in the future should Defendant default on the payments, and that
7 any limitation stated in Nevada Rules of Civil Procedure 41(e) is hereby waived in its entirety by
8 Defendant.


