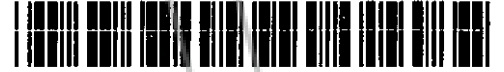

Said attorney-in-fact is authorized to execute a deed on our behalf.

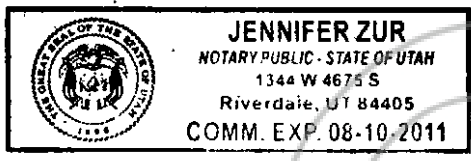

**A timeshare estate comprised of:**
