WHEREAS, Douglas County, is a political subdivision of the State of Nevada, and requires the services of independent contractors; and

WHEREAS, on August 19, 2010 Douglas County entered into a contract for professional services to temporarily employ Senior Justice of the Peace Steven D. McMorris pursuant to S.C.R. 12(6), NRS 4.032 and NRS 4.340 for East Fork Justice Court.

WHEREAS, the contract for professional services was effective for a thirty (30) day time period, August 9, 2010 through September 8, 2010.

WHEREAS, the contract for professional services included an option to renew the contract for an additional thirty (30) day time period, September 9, 2010 through October 9, 2010; and

WHEREAS, the parties intend to renew the contract for an additional thirty (30) days.

WHEREAS, it is deemed that the services of Contractor herein specified are both necessary and desirable and in the best interests of Douglas County; and

WHEREAS, Contractor represents that he is duly qualified, equipped, staffed, ready, willing and able to perform and render the services hereinafter described;

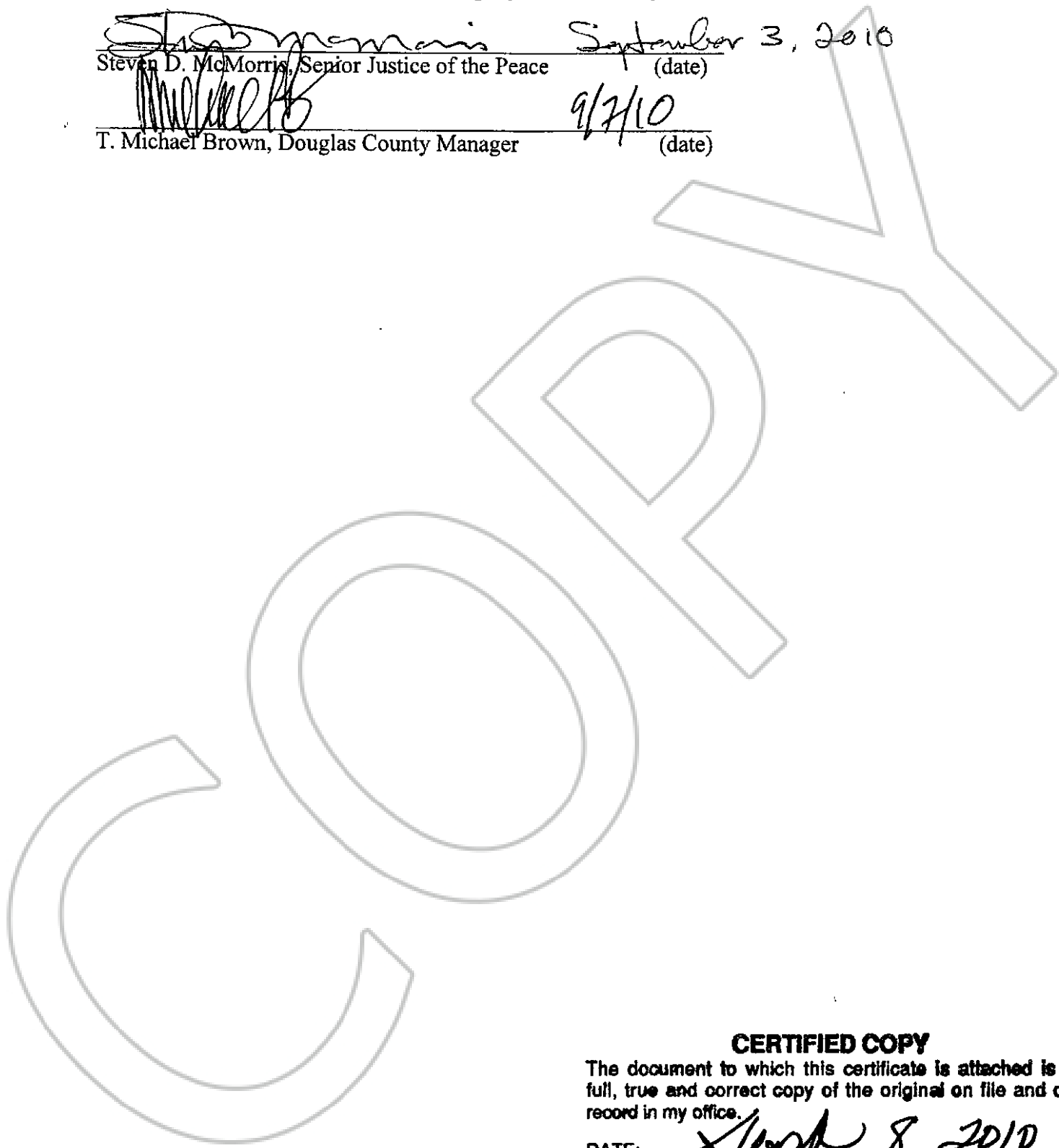
NOW, THEREFORE, in consideration of the agreements herein made, the parties mutually agree as follows:
