

Dear Mr. Eiguren:

Douglas County staff recently performed an inspection of the Sierra Nevada Golf Ranch Clubhouse to identify sewer equivalent dwelling units (EDUs) currently connected to the public sewer. This inspection was performed with Mr. Chandler from your office.

Based on the inspection, staff calculated 28.90 sewer EDUs. This calculation includes 2.25 EDUs of fixtures that have been temporarily disconnected. Based on current utility practices, these fixtures are included in the calculation. If you wish to permanently remove the fixtures, we can reduce the sewer EDUs from 28.90 to 26.65 and adjust the connection fee accordingly.

Pursuant to the April 7, 2005 Water and Sewer Facilities Agreement, the County will credit Genoa Golf Investors, LLC (GGI) 17 EDUs for connection of the clubhouse and office facilities to the public sewer. Based on the current fixture count, a balance of \$68,544 is due and payable to the County. Attached is Connection Permit C190-00 for this amount. Please sign and remit payment to Douglas County.
