

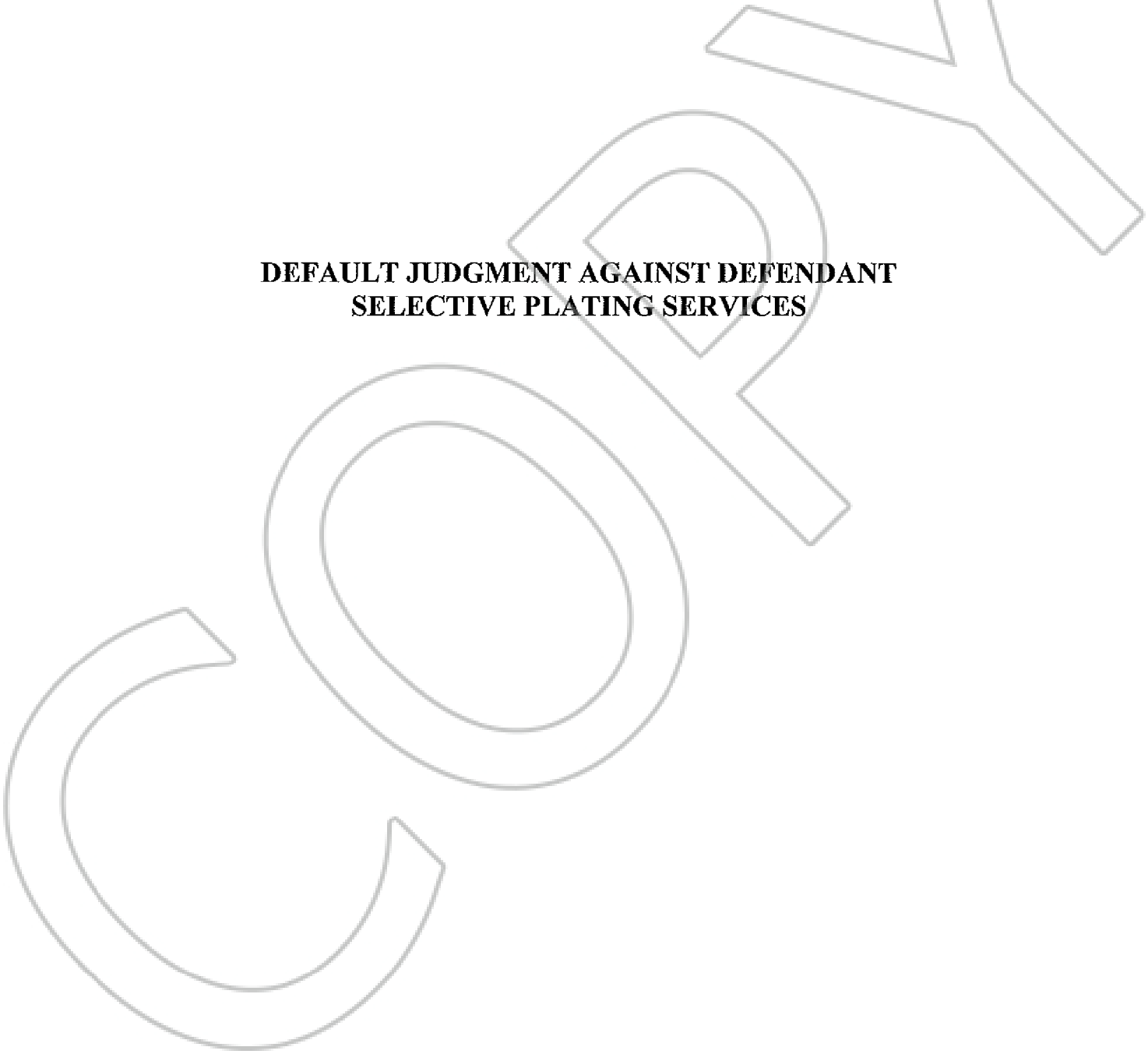

1 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that Judgment is hereby entered  
2 against Defendant SELECTIVE PLATING SERVICES, and in favor of Plaintiff, MCBRIDE'S, in the  
3 principal amount of \$26,669.93.

4 IT IS FURTHER ORDERED that this Judgment shall include pre-judgment interest at the  
5 contractual rate of 18% per annum from the date the principal became due in the amount of  
6 \$17,093.30, and shall continue to accrue such interest on the unpaid balance until paid in full.

7 IT IS FURTHER ORDERED that this Judgment shall include attorneys' fees against  
8 Defendant SELECTIVE PLATING SERVICES, as allowed for by the contract and pursuant to the  
9 affidavit in support of attorneys' fees in the amount of \$ \_\_\_\_\_.

10 IT IS FURTHER ORDERED that this Judgment shall include costs against Defendant  
11 SELECTIVE PLATING SERVICES in the amount of \$574.81 pursuant to the Memorandum of Costs  
12 and Disbursements.
