6 amount of \$ 125<sup>00</sup>.



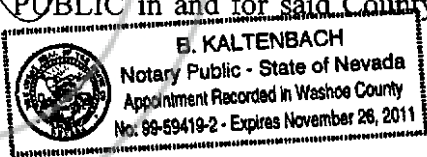
