With the Court finding good cause and based on the documents on file, the following is issued:

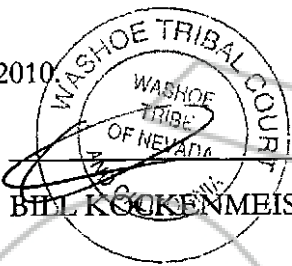
FINDINGS OF FACT
