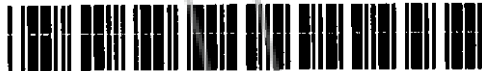



19 IT IS HEREBY ORDERED that judgment is entered on behalf of the Plaintiff against
20 MICHELLE A. GARCIA, in the principal amount of \$1,820.69, plus prejudgment interest at
21 the rate of 19.000% per annum from August 19, 2010 until entry of judgment, plus attorney's
22 fees of \$200.00, plus costs of suit in the amount of \$111.00, with post-judgment interest
23 accruing on the entire judgment at the legal rate from the date of entry of judgment.

IT IS FURTHER ORDERED that Plaintiff shall refrain from execution on the judgment provided MICHELLE A. GARCIA voluntarily pays Plaintiff the sum of \$2,029.30, plus interest and costs, and without attorney's fees, in accordance with the following schedule:

Commencing December 20, 2010, \$125.00 per month due on or before the 20th day of each month and continuing thereafter until paid in full.

Each payment shall be applied first to any outstanding interest with the remainder applied to the unpaid judgment which contains costs, fees, principal and prejudgment interest.

In the event of default by MICHELLE A. GARCIA under the stipulated payment plan, Plaintiff shall be entitled to execute on the full judgment, which includes attorney's fees in the amount of \$200.00, with post-judgment interest accruing on the entire judgment at the legal rate from the date of entry of judgment.
