THIS MATTER was brought on before the Court on the $14^{\rm th}$ day of Present in Court were the Executrix of the Estate of March, 2011. the Decedent, NANCY LEE FULLINGIM, together with her counsel, MICHAEL SMILEY ROWE, ESQ. of ROWE & HALES, LLP.

On 17 February 2011 the Executrix filed her Verified Inventory and her Request for Order Extinguishing Life Estate of Property Attached as Exhibit "A" to the Verified Inventory of ("Request"). Property and the Request was a letter dated 16 December 2010 from Lora Dean Giovacchini ("Lora") wherein Lora stated:

On the basis of the 16 December 2010 letter from Lora, the Executrix has requested that the Court enter its Order terminating the life estate provided in Article 5 of the Decedent's Last Will and Testament.

At the time of the hearing on 14 March 2011, no person appeared in opposition to the Request to Extinguish the Life Estate provided in the Decedent's Last Will and Testament.

Based upon all pleadings on file herein, and the request of the Executrix to extinguish the life estate appointed by the Last Will and Testament of the Decedent, and good cause appearing, it is hereby found, concluded and ordered as follows:

- The Court finds that the Last Will and Testament of the Decedent has been duly and properly admitted to probate. correct copy of the Last Will and Testament of William James Nunn, Deceased, was attached as Exhibit "B" to the Verified Petition for Letters Testamentary filed 9 November 2010.
- Pursuant to Article 5 of the Decedent's Last Will and Testament, the Decedent gave, devised and bequeathed to Lora Dean Giovacchini a life estate in the real property located at 3486 Mark Twain Avenue, Gardnerville, Douglas County, Nevada, together with all items of personal property included therein, for so long as she would The Decedent's Last make beneficial use and enjoyment of the same. Will and Testament further provides that, upon the death of Lora Dean Giovacchini, or upon the earlier termination of the Decedent's gift of a life estate, the Decedent's Will provides that the remainder interest in the real property and improvements located at 3486 Mark

3. The Court finds as a matter of fact, and concludes as a matter of law, that due and proper notice of the Request was supplied to Lora Dean Giovacchini. As noted, Exhibit "A" to the Verified Inventory of Property and Request is a letter from Lora with an address of 73 Arrowhead Drive, Carson City, Nevada 89706.

The Court finds that a copy of the Request, together with a copy of the Notice of Hearing to be conducted on 14 March 2011 was provided to Lora at her current address. The Court concludes as a matter of law that the requirements of notice specified in NRS 155.010(1)(a) have been met by the Executrix. As noted, no opposition to the Request has been received by the Executrix or by the Court.

Based upon the above-stated findings of fact and conclusions of law, the Court hereby Orders as follows:

IT IS HEREBY ORDERED that the life estate provided by the Decedent in Article 5 of his Last Will and Testament to Lora Dean Giovacchini in the real property, improvements and personal property located within the residence, shall be, and the same is hereby, terminated.

Hereinafter, all rights, title and interest in and to the real property, improvements and personal property, described below, shall be given, devised and bequeathed as provided in Article 6 of the Last Will and Testament of the Decedent.
