

ORDER SETTLING AMENDED FIRST AND FINAL ACCOUNTING, AND PETITION FOR APPROVAL OF PAYMENT OF ATTORNEY FEES, AND FOR FINAL DISTRIBUTION OF **ESTATE**

The verified FIRST AND FINAL ACCOUNTING, AND PETITION FOR APPROVAL OF PAYMENT OF ATTORNEY FEES, AND FOR FINAL DISTRIBUTION OF ESTATE filed by RONALD CRAIG DOUGAN, as Executor of the Estate of BARBARA ANN DOUGAN, came regularly for hearing before this Court on February 28, 2011. Two of the Decedent's children appeared at the February 14, 2011 hearing to orally object to the original petition, so the matter was continued until February 28, 2011. One of the objections raised was the misspelling of the children's names (the Last Will and Testament contained misspelled names). Therefore, new Notices of Hearing were sent, with the "McDonald" names corrected to "MacDonald." Also, a verified amended petition was filed correcting the names and verifying

that no other assets were subject to probate in either Oregon or Nevada. The Decedent's Oregon attorney, Scott K. Thompson, also signed the verified amended petition reporting that shortly before her death, the Decedent presented the May 25, 1977 Last Will and Testament to him and reported it was her currently effective Last Will and Testament. Mr. Thompson also verified that the Decedent told him she desired to transfer the Douglas County Nevada property into joint tenancy deeds with her husband, Ronald Craig Dougan, but the Decedent became too ill to finalize the transfer. It was a long term marriage between the Decedent and Ronald Craig Dougan. If this probate is allowed to close, it will transfer the real property to the Decedent's husband Ronald Craig Dougan.

On February 28, 2011 the Decedent's daughter, Lisa MacDonald (or Lisa Macdonald), appeared to again object to the petition seeking to close the estate. Her objection was based on her belief that the Decedent had executed a Last Will and Testament replacing the May 25, 1977 Last Will and Testament submitted for probate in this matter. Ms. MacDonald (or Macdonald) said she did not have this Last Will and Testament in her possession and did not know of its whereabouts. Ms. MacDonald (or Macdonald) requested time to search for the document, which no family member had ever seen. Ms. MacDonald (or Macdonald)'s only evidence was that the Decedent's son had reported the Decedent wrote him a letter in the 1990's claiming to have executed a new Last will and Testament. The Court gave Ms. MacDonald (or Macdonald) a thirty day continuance to locate and file any alleged later-executed Last Will and Testament. The Court warned Ms. MacDonald (or Macdonald) that if she did not file any formal paperwork prior to the April 4, 2011 hearing, the Court would grant the petition to close probate under the May 25, 1977 Last Will and Testament without any further hearing or any further appearance required by Petitioner's counsel.

On proof made to its satisfaction, the Court finds that:

Notice of hearing has been duly given as required by law;

- 2. Notice to creditors has been given as required by law;
- 3. All known creditors of the Estate have been paid;
- 4. All income taxes, Estate taxes, and property taxes chargeable against the Estate have been paid personally by the Executor;
 - 5. All the allegations in the accounting and petition are true; and
- The Estate should be settled, distribution made, and commissions and fees paid as requested.

THEREFORE, IT IS ORDERED:

- 1. That the administration of the Estate of BARBARA ANN DOUGAN, Decedent, is settled, approved without any further accounting, and is brought to a close;
- That the First and Final Accounting of the Executor/Personal Representative is allowed, settled and approved as filed;
- That all acts and transactions of the Executor/Personal Representative relating to matters set forth in the accounting and petition are confirmed and approved;
- 4. That the Executor/Personal Representative has waived his rights to statutory and extraordinary Executor fees, and requests no compensation for services rendered as the Executor/Personal Representative;
- 5. That the Executor/Personal Representative is authorized and directed as per NRS Section 150.060 to pay the law firm of Rachelle J. Nicolle, attorney for the Estate, the sum of \$8,860.00 in fees plus \$1,106.53 in expenses, minus the retainer amount of \$850, for a total of \$9,116.53 still owed the attorney as reasonable compensation for legal services rendered during the administration of the Estate, plus any additional costs by the law firm on behalf of the Estate;

- 6. That the Executor/Personal Representatives is authorized and ordered to personally pay attorney and accountant fees and future additional Estate expenses owed to Scott K. Thompson and Rachelle J. Nicolle;
- 7. That the petition for final distribution is granted and the Court orders for final distribution as follows:

Balance Total Remaining Assets to be distributed as follows: \$ 660,000.00

1. RONALD CRAIG DOUGAN (sole residuary devisee)
Real Property at 1565 Chiquita, Minden, NV: \$ 220,000.00

That the real property located at 1565 Chiquita, Minden, NV 89423, Douglas County, NV, under APN 1420-34-811-018, and more particularly described as follows: Lot 16, in El Rancho Estates, Douglas County, Nevada, being a portion of the SE ¼ of the SE ¼ of Section 34, Township 14 North, Range 20 East, M.D.B. & M., (Per NRS 111.312, this legal description was previously recorded at Document No. 79580, Book No. 475, Page 704, on April 23, 1975), be titled as follows to "Ronald Craig Dougan, a widower." That the Executor/Personal Representative is authorized to issue a Grant Deed to transfer the Estate's real property to Ronald Craig Dougan, a widower.
- 9. That the real property located at 1579 Chiquita, Minden, NV 89423, Douglas County, NV, under APN 1420-34-811-022, and more particularly described as follows: Lot 12, in El Rancho Estates, Douglas County, Nevada, being a portion of the SE ¼ of the SE ¼ of Section 34 N., Range 20 East, (Per NRS 111.312, this legal description was previously recorded at Document No. 39867, Book No. 1279, Page 1244, on

December 20, 1979), be titled as follows to "Ronald Craig Dougan, a widower." That the Executor/Personal Representative is authorized to issue a Grant Deed to transfer the Estate's real property to Ronald Craig Dougan, a widower.

- 10. That the real property located at 2613 Squires, Minden, NV 89423, Douglas County, NV, under APN 1420-34-811-032, and more particularly described as follows: Lot 2, in El Rancho Estates, Douglas County, Nevada, being a portion of the SE ¼ of the SE ¼ of Section 34, Township 14 North, Range 20 East, M.D.B. & M., (Per NRS 111.312, this legal description was previously recorded at Document No. 79583, Book No. 475, Page 707, on April 23, 1975), be titled as follows to "Ronald Craig Dougan, a widower." That the Executor/Personal Representative is authorized to issue a Grant Deed to transfer the Estate's real property to Ronald Craig Dougan, a widower.
