The undersigned hereby certifies that on January 19, 1999, she and Howard O. Smythe created a revocable Living Trust. This Trust is known as: THE H & E SMYTHE TRUST dated January 19, 1999. Howard O. Smythe and Evelyn M. Smythe were the original Trustors and Trustees.

The undersigned hereto desires to confirm the establishment of a revocable and amendable Living Trust on January 19, 1999, and amendments thereto, for the benefit of the Trustors and containing inter alia the following provisions:

- 3. The Trust is Revocable by the Trustors jointly or upon order of a Court of competent jurisdiction;
- 4. Any Trustee has the power and authority to manage and control, buy, sell and transfer the Trust property, in such manner as the Trustee may deem advisable, and shall have, enjoy and exercise all powers and rights over and concerning said property and the proceeds thereof as fully and amply as though said Trustee were the absolute and unqualified owner of same, including the power to grant, bargain, sell and convey, encumber and hypothecate, real and personal property, and the power to invest in corporate obligations of every kind, stocks, preferred or common, and to buy stocks, bonds and similar investments on margin or other leveraged accounts, except to the extent that such management would cause includability of an irrevocable Trust in the estate of a Trustee.
