Owner intends to seek a refund of the fees submitted with this Affidavit if (a) NRS 517.187 is declared to be unconstitutional; (b) NRS 517.187 is repealed; or (c) NRS 517.187 is amended to reduce the amount of the fees. The additional mining claim fees submitted with this Affidavit are paid under protest as provided in NRS 361.420 and NRS 353.110.
