John W. Gerken Trustee, hereby reconveys all his right title and interest to the trustor named therein.

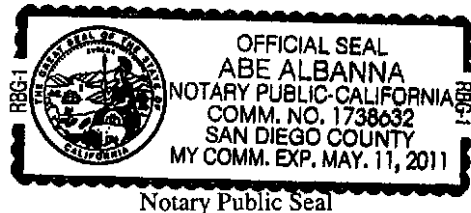
