WATER RIGHTS DEED

THIS INDENTURE is made this 30 day of JUNE, 2011, by and between **Mottsville Limited Partnership II ("Grantor")** and, **Scott Forvilly, a married man and Frank Forvilly a married man, together as tenants in common ("Grantee")**.

WHEREAS, Grantor, for and in consideration of the sum of Ten Dollars (\$10.00), and other good and valuable consideration, to it acknowledged, does hereby quitclaim to Grantee, and to its successors and assigns forever, Vested Right # 06315 of the Mott Canyon Creek in the Priority 1862 for a total of 40 irrigated acres or 160 ac.-ft. annually. (See attached table of water rights) Said water rights being located in Douglas County and more particularly described as:

160 acre feet, and 58 hours per week of the total flow of Mott Canyon Creek for Vested Permit number 06315 as registered with the State of Nevada, Division of Water Resources, together with a proportionate share of the rate of diversion, which are located on and appurtenant to that certain real property situated in the County of Douglas, State of Nevada, described as follows:

TOGETHER WITH all and singular the tenements, hereditaments and appurtenances thereupon belonging or appertaining and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.

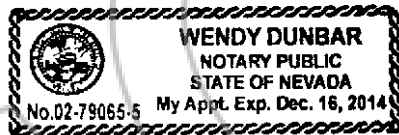

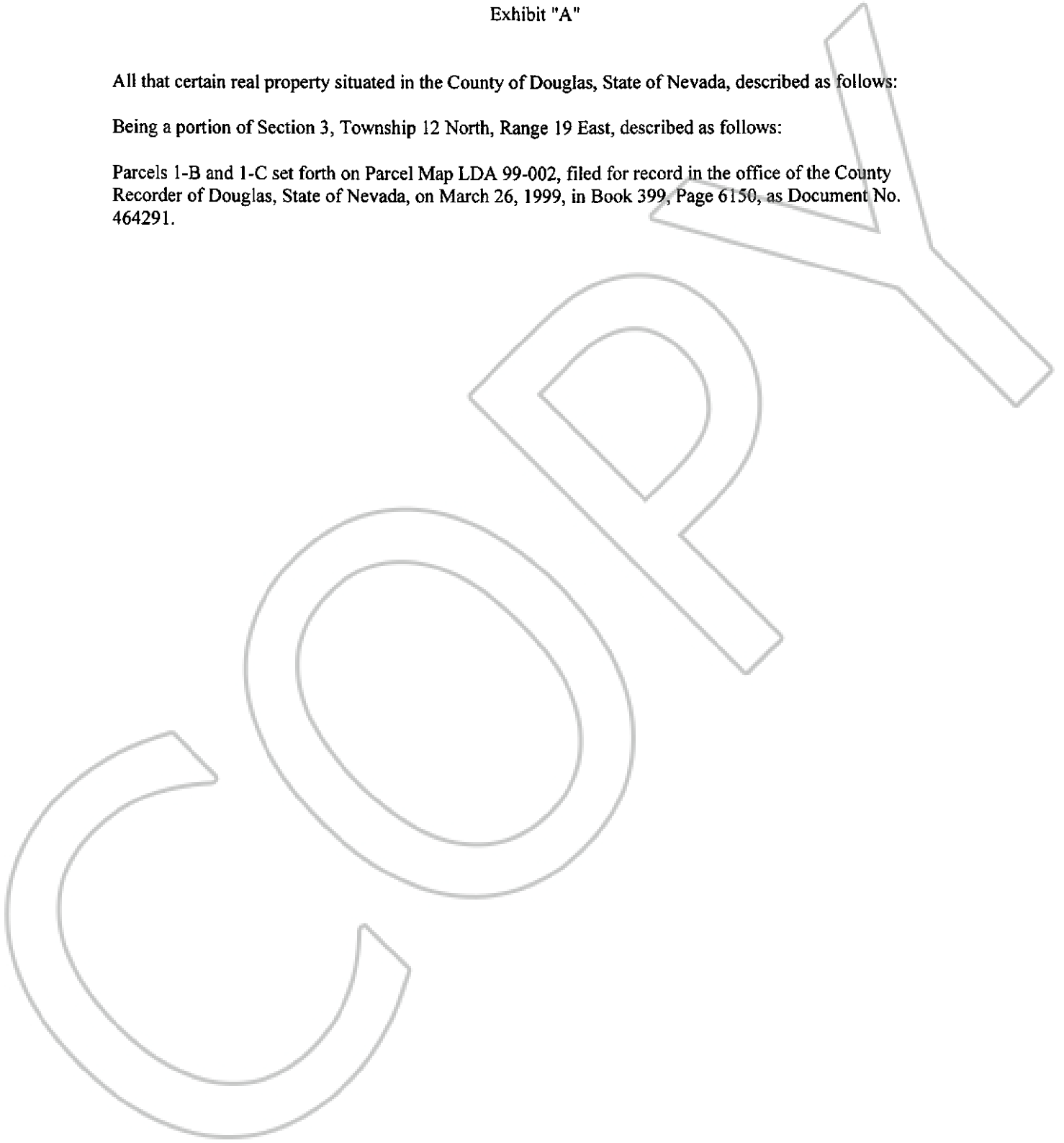
