## AFFIDAVIT - DEATH OF TRUSTEE

I, TIMOTHY W. DAVID, being duly sworn, say:

- 1. That I am 18 years of age or over.
- 2. That EVAN HYDE DAVID, the decedent mentioned in the attached certified copy of Certificate of Death, is the same person as EVAN HYDE DAVID, named as a Trustee in the Grant Deed dated February 12, 1999, executed by EVAN HYDE DAVID, as Grantor. Said deed granted title to EVAN HYDE DAVID as Trustee of THE EVAN HYDE DAVID REVOCABLE LIVING TRUST under Declaration of Trust dated December 29, 1998, and to any Successor Trustee, and was recorded on June 21, 1999, as Document Number 470732, in the Official Records of Douglas County, State of Nevada, which conveyed the property described herein below to EVAN HYDE DAVID, Trustee of THE EVAN HYDE DAVID REVOCABLE LIVING TRUST under Declaration of Trust dated December 29, 1998.

- 3. That EVAN HYDE DAVID died on March 7, 2011, and that as a result of his death, TIMOTHY W. DAVID is appointed by the terms of THE EVAN HYDE DAVID REVOCABLE LIVING TRUST under Declaration of Trust dated December 29, 1998, ("Trust") to act as sole Trustee of the Trust.
- 4. That the Trust is in full force and effect, and that TIMOTHY W. DAVID is qualified and has the power to act as Trustee of the Trust and to exercise the powers granted him under the Trust in his capacity as Trustee of the Trust.

- That the entire interest of the Trust in the above-described real property is now vested in title as follows: "TIMOTHY W. DAVID, Successor Trustee of THE EVAN HYDE DAVID REVOCABLE LIVING TRUST under Declaration of Trust dated December 29, 1998."
